



## List of Applicable Product Requirements

---

In accordance with the ACRS Product Certification Scheme Rules, certification of reinforcing steels, general steels and associated products may take place against the following applicable Product Requirements.

Where a Firm is Certified under the Scheme to a Product Class, all materials within that Product Class that are supplied to these Product Requirements by the Firm are Assessable Materials under the Scheme:

1. Concrete Reinforcing Steels:
  - a) AS/NZS 4671: 2001, *Steel reinforcing materials*;
  - b) AS/NZS 4672: 2007, *Steel prestressing materials*;
  - c) BS 6744: 2016 *Stainless Steel Bars – Reinforcement of Concrete – Requirements and Test Methods*
2. Hot-rolled Structural Steels:
  - a) AS 3597:2008, *Structural & pressure vessel steel – Quenched & tempered plate*;
  - b) AS/NZS 1594:2002, *Hot-rolled steel flat products*;
  - c) AS/NZS 3678:2016, *Structural steel – Hot-rolled plates, floorplates and slabs*;
  - d) AS/NZS 3679.1:2016, *Structural steel – Hot-rolled bars & sections*;
  - e) AS/NZS 3679.2:2016, *Structural steel – Welded I sections*;
  - f) AS/NZS 5131:2016, *Structural steelwork – Fabrication and erection*<sup>1</sup>
3. Cold-formed Structural Steels:
  - a) AS 1579-2001 (R2018) *Arc-welded steel pipes and fittings for water and waste-water*;
  - b) AS/NZS 1163:2016, *Cold-formed structural steel hollow sections*;
  - c) BS EN 10219: 2006, *Cold formed welded structural hollow sections of non-alloy and fine grain steels*
4. Ancillary Products:
  - a) ACRS Technical Approval “*Reinforcement couplers*”;
  - b) AS/NZS 1252:2016, *High-strength steel fastener assemblies for structural engineering – Bolts, nuts and washers*.

In addition to the above Product Requirements, any Product Class may also be required to be Approved to the Product Requirements stipulated by:

- a) AS 1074-1989 (R2018) *Steel tubes and tubulars for ordinary service*;
